

NOTICE OF UTILITY INCREASE

NOTICE OF OKC WATER COST INCREASE EFFECTIVE BEGINNING APRIL 1ST

Dear City of Blanchard Resident,

Since Oklahoma City has increased the cost of water being supplied to Blanchard, we must pass that increase along to our customers. The City of Blanchard adds no additional markup to these charges. This increase is an exact reflection of the increase incurred by Blanchard from Oklahoma City. For over 30 years, Blanchard has purchased 100% of its water from Oklahoma City. Consequently, Oklahoma City indirectly sets the water rate that Blanchard charges by the cost that they sell water to every city they serve. On January 1, 2025, Oklahoma City increased their price of water by 5.7%. Therefore, Blanchard's rates must also increase by that same 5.7%. These new rates will become effective on April 1, 2025. Refer to the following rate chart for the new water rates in Blanchard.

The rates will change as follows "per thousand gallons":
